Approval of Minutes: Consideration of Minutes for Meetings of March 23, 2022 and September 14, 2022. Motion made by Ms. Maneva, seconded by Mr. David, to continue the minutes to the December 14, 2022 meeting at 7:00 pm. Unanimous.

The following members are present: Stephen David, Chairman, Debra Odeh, Elias Fares, Vesna Maneva, and Grace Weller. Absent are Todd Sullivan and R.J. Sheer. Conservation Agent, Karon Skinner Catrone is also present. Mr. David announces this meeting is being recorded.

Action Items:

1. Hazard Mitigation Plan - BETA – Presentation – Present are Emily Farmer and Emily Slotnick of BETA. Ms. Farmer explains that DPW, police, youth and family services, Board of Health, Fire, Conservation, Council on Aging, Library Community and Economic Development and GIS were involved with the development of this plan. She states there was a lot of information needed from Ms. Catrone. She states she will be going over the following topics with the Commission this evening: overview and benefits of hazard mitigation planning, mitigation planning process and content, the 2022 mitigation strategy and the adoption process. With this plan the town will be eligible for grants. This will also play a role in climate change. We have work with all of the boards and had a public visioning session last week. The plan was sent to MEMA and FEMA today for their approval.

Following the presentation, Mr. David thanks Ms. Farmer and Ms. Slotnick for their presentation tonight.

Public Hearings:

510 Far Reach - Stormwater Land Disturbance - Gandhi

The Commission opened the public hearing and reviewed copies of the Land Disturbance Permit for 510 Far Reach Road for disturbance of over ½ acre of land, including the following:

- 1. Land Disturbance Application submitted on September 30, 2022 by Christopher Cabral of Crossman Engineering, 103 Commonwealth Avenue, North Attleboro, MA 02763, including one (1) page;
- 2. Plan PROPOSED SINGLE FAMILY RESIDENCE PLAT MAP 2, LOT 45 ZONING DISTRICT SRC 510 FAR REACH ROAD WESTWOOD, MASSACHUSETTS, dated April 2018, last revised 7/26/22, submitted by Crossman Engineering, including one (1) page;

Present is Christopher Cabral of Crossman Engineering requesting a Land Disturbance Permit for the construction of a new single family home and grading.

Ms. Catrone explains that this project was initially filed for as an Administrative Land Disturbance Permit and was issued for disturbance of under ½ acre of land. In late summer she visited the site with Mike Perkins of the building department and found additional disturbance on the site. At that time, it was discovered that he owner was doing additional work on the site which brought the land disturbance to over ½ acre of work. A cease and desist was issued by the building department. She states the project is currently being reviewed by BETA. The review is not complete.

Ms. Odeh states she lives in this neighborhood and has watched the work. There has been significant additional disturbance. A lot of trees have been removed and a lot of fill brought in. This project needs to be done right. Vegetation to prevent erosion is necessary. Currently there is soil just dumped on the site. She states she would like to see a detailed planting plan, not just lawn.

The Commission agrees they cannot approve the project without the completed peer review.

Motion made by Mr. David, seconded by Ms. Odeh to continue this hearing to December 14, 2022 at 7:00 pm to allow BETA to complete the peer review. Unanimous.
