NOTICE OF PUBLIC HEARING 154 University Avenue – Dedham-Westwood Water District (DWWD)

Pursuant to Chapter 20 of the Acts of 2021, on March 29, 2023, Governor Healey signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency. This Act includes an extension, until March 31, 2025, of the remote meeting provisions the previous administration's March 12, 2020, Executive Order. This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. The Westwood Planning Board will hold a remote public hearing on **Wednesday**, **April 24**, **2024 at 7:00 p.m. via Zoom** regarding an application filed by Aaron Guazzaloca on behalf of Weston & Sampson for consideration of an Environmental Impact and Design Review (EIDR) pursuant to Section 7.3 of the Westwood Zoning Bylaw for the purposes of constructing a roughly 2,831 sq. ft. addition on the east (street-facing) side of the building to house a PFAS treatment system for the DWWD White Lodge Treatment Plant at 154 University Ave., Westwood, MA 02090 in accordance with PB-24-7. The property is in the Industrial (I) zoning district and within the University Avenue Mixed Use District (UAMUD) and Water Resource Protection Overlay District (WRPOD).
