Call to Order

Chair Update

Mr. Cummings was present. The ribbon cutting ceremony was last Friday, thank you to everyone for attending. In particular, thank you to this group for making it all possible, coming to every meeting prepared, focused and ready to complete the task at hand, a strong reason the school building is on time and on budget.

The fence on Gay Street is the construction fence that's required for public safety, closing off the construction site from the sidewalk, the fields and demolition of the Hanlon. The original plan was to replace the sidewalk as they were demoing the Hanlon School. When that plan changed, we asked them to put a parallel fence inside of the sidewalk, and reopen the sidewalk until construction of the sidewalks began

The plan is still to remove and replace the sidewalk from the Croft Regis crosswalk, toward 109, the School's south entrance road. When that's done, the fence will be removed. Then the sidewalk from the Croft Regis crosswalk to the north entrance will be closed so the construction crew can remove and replace the sidewalk.

There will be activity during the April vacation break as the students will not be there. They'll be working full days on the punch list as well as landscaping. This week they are removing the slab on grade, and foundations.
