Pursuant to Chapter 40A, §9, the Board of Appeals will hold a public hearing on Wednesday, June 12, 2024, at 7:00 PM. The public hearing will be a remote meeting through Zoom. On March 29, 2023 Governor Maura Healey signed into law, the Acts of 2023, which includes an extension to pandemic related authorizations related to public meetings. The extension allows a remote meeting option for public bodies through March 31, 2025. Those wishing to participate are encouraged to use Zoom.

The Board shall hear an application filed by Patrick Beerman for a Special Permit pursuant to the Westwood Zoning Bylaw Sections §4.3.3.12 [Accessory Uses – Accessory Apartments] and §8.5 [Accessory Apartments]. The Petitioner proposes to construct an accessory apartment addition over an existing two car garage attached to a single-family home. The property is located in the SRE (Single Residential E) zoning district.

Any zoning relief that may be required in adherence to the Westwood Zoning Bylaw shall be considered by the Board.
