NOTICE OF PUBLIC HEARING 693 High Street – Medical Aesthetics

Pursuant to Chapter 20 of the Acts of 2021, on March 29, 2023, Governor Healey signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency.
