Pursuant to Chapter 20 of the Acts of 2021, on March 29, 2023, Governor Healey signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency. This Act includes an extension, until March 31, 2025, of the remote meeting provisions the previous administration's March 12, 2020, Executive Order. This meeting will be conducted via remote means. The Westwood Planning Board will hold a remote public hearing on **Tuesday, September 24, 2024 at 7:00 p.m. via Zoom** regarding an application filed by Justin Ferris on behalf of Westwood Realty Ventures LLC for consideration of an Environmental Impact and Design Review (EIDR) Approval pursuant to Section 7.3 of the Westwood Zoning Bylaw for the purposes of a change of use from a hair salon to a shipping and printing business with interior cosmetic alterations in Lamberts Plaza at 220 Providence Highway, Westwood, MA 02090 in accordance with PB-24-37. The property is in the Single Residence B (SRB) zoning district.
