## NOTICE OF PUBLIC HEARING 637 High Street - Fire Station 1

Pursuant to Chapter 20 of the Acts of 2021, on March 29, 2023, Governor Healey signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency. This Act includes an extension, until March 31, 2025, of the remote meeting provisions the previous administration's March 12, 2020, Executive Order. This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. The Westwood Planning Board will hold a remote public hearing on Tuesday, September 24, 2024 at 7:00 p.m. via Zoom regarding an application filed by the Town of Westwood for consideration of an Environmental Impact & Design Review approval pursuant to Section 7.3 of the Westwood Zoning Bylaw for the purposes of demolishing the existing Fire Station 1 and building a new 35,833 gross square foot station, including but not limited to, apparatus bays, offices, conference and training areas, decontamination areas, triage area, maintenance bay, utility spaces, dormitories, kitchen, dining and living areas, restrooms, laundry facilities, and fitness room, with associated exterior lighting, landscaping, utilities, drainage, mechanical equipment, generator, and onsite parking, at 637 High Street, Westwood, MA 02090 in accordance with PB-24-43. The property is in the Single Residence C (SRC) zoning district and within Upper Story Residential Overlay District (USROD), Wireless Communications Overlay District (WCOD), and Water Resource Protection Overlay District (WRPOD).
