Pursuant to Chapter 40A, §9, the Board of Appeals will hold a public hearing on Wednesday, November 13, 2024, at 7:00 PM. The public hearing will be a remote meeting through Zoom. On March 29, 2023 Governor Maura Healey signed into law, the Acts of 2023, which includes an extension to pandemic related authorizations related to public meetings. The Board shall hear an application filed by the Town of Westwood for a Special Permit pursuant to the Westwood Zoning Bylaw Section §4.1.7.4 [Temporary Use & Structure]. The Petitioner proposes to construct a temporary structure and place a modular trailer on site to serve as temporary Fire Department operations while the new fire station is being constructed. The proposed temporary facilities will include a modular trailer to house fire department personnel and a temporary metal framed structure to house the fire apparatus vehicles. The property is in the Single Residence C (SRC) zoning district, and within the Water Resource Protection Overlay District (WRPOD).

Land affected: 90 Deerfield Avenue
Map 14, Lot 095

Any zoning relief that may be required in adherence to the Westwood Zoning Bylaw shall be considered by the Board.

Should any person or party desire for any written material, including legal arguments or positions, to be considered by the Zoning Board of Appeals in connection with any petition before the Board, such material shall be submitted to the clerk of the Board no later than five (5) calendar days before the public hearing on the petition, or such material shall not be considered.
