## NOTICE OF PUBLIC HEARING Westwood A Better, Bright Future Climate Action, Resiliency & Sustainability Plan Update

Pursuant to Chapter 20 of the Acts of 2021, on March 29, 2023, Governor Healey signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency. This Act includes an extension, until March 31, 2025, of the remote meeting provisions the previous administration's March 12, 2020, Executive Order. This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. This long-range town-wide plan is a visionary document setting goals and recommended actions for Westwood through 2060. The Planning Board will review and take public comments.
