Background

Date Built: 2004 High School Gymnasium, Auditorium, Little Theater, Recreation Offices and Toilet Rooms at the Football Field. Pool Built: 1972 Pool Renovated: 2006 and 2023

Family Changing Rooms Built: 2012

The Town asked IHCD to focus on specific areas of Westwood High School that are open to the public for non-school related events. These areas include a softball field, two (2) synthetic turf fields, the auditorium, an auxiliary theater called "Little Theater", the gymnasium, pool, and Town Recreation Department. The auditorium is used for public meetings, the Little Theater is used as overflow space for public meetings, and both areas can be rented by the public. In addition to the areas that were mentioned previously, men's and women's toilet rooms near the auditorium, and family changing rooms, locker rooms and men's and women's toilet rooms near the pool were surveyed. All areas are on the first floor of the building.

Westwood High School is a two-story building located at 200 Nahatan Street. It has three (3) entrances with one (1) main entrance on the east side. Vertical circulation consists of two (2) elevators, six (6) sets of stairs, and one (1) interior ramp.

Exterior amenities include parking lots located on the north, east, and south sides of the building and a courtyard. The IHCD team surveyed the parking (an east lot by the tennis court, an east parking lot by the school, and a north parking lot), a softball field, a baseball field, practice areas, a soccer field, a volleyball court, a football field, bleachers, and the men's and women's toilet rooms near the football field.

Note: The IHCD team only surveyed areas that will be used for non-school public programs and did not survey the entire high school. The press box and the lift leading to the press box were locked and unable to be surveyed. The south parking lot is not near any of the public non-school related portions of the school and so was not part of the survey.

Key Accessibility Issues

Exterior Access Route Accessibility issues include excessive running and cross slopes, routes that are not maintained in operable working condition, routes with excessive changes in level and surface openings, lack of accessible routes to a bike rack, a softball field, team seating areas at the softball field, a baseball field, baseball field team seating areas, spectator seating areas, practice areas, a volleyball court, a batting cage, a soccer field, a long jump area, a shot put area and sideline seating areas.

Parking

Accessibility issues include lack of two (2) car accessible spaces and a van accessible space in the east lot by the tennis court, lack of two (2) car accessible spaces in the north lot by the football field, lack of one (1) sign with the International Symbol of Accessibility (ISA) at an accessible parking space in the north lot by the football field, and accessible signs located lower than allowed in the east and north lots.

Signage

Accessibility issues include lack of tactile designation signage at each permanent room or space, lack of a tactile exit signs, noncompliant designation signage, lack of directional signs to accessible emergency exits at inaccessible exit doors, and lack of illuminated International Symbol of Accessibility (ISA) at accessible egress doors.

Note: When or if an illuminated exit sign is repaired or replaced, provide an illuminated sign with the International Symbol of Accessibility (ISA).

Doors and Doorways than allowed.

Accessibility issues at doors include doors that lack an adequate amount of clear width, doors that close faster than allowed, lack of door maneuvering clearance at some doors, doors that require excessive opening force and one (1) door threshold that is higher

Ramps

Accessibility issues include excessive running slopes, lack of compliant handrails, and handrails that are not located properly.

Stairs


Accessibility issues include handrails that are mounted lower than allowed.

Lifts

Accessibility issues include lack of a compliant platform lift in the auditorium and between the auditorium and the recreation office, and lack of an independently operable lift to the pool.

Assembly Areas

Accessibility issues include lack of the minimum number of wheelchair spaces in the auditorium, the auxiliary theater, the football stadium, and the pool; lack of accessible spaces at sideline seating areas near the softball and baseball fields; and lack of shoulder alignment between the companion and wheelchair spaces in the football field bleacher, auxiliary theater and auditorium. See the following diagrams showing shoulder to shoulder alignment and measurements of wheelchair seating alongside bleachers:



Regarding assistive listening in the auditorium, auxiliary theater, gym, and football field stadium, IHCD is concerned that there are not enough receivers able to be checked out by the public from the Town Clerk's office if meetings or events go on simultaneously at these spaces. IHCD was informed that there are approximately four (4) personal hearing devices available. Based on the capacities of each area: 36 receivers (9 of which are hearing aid compatible) should be available for the football stadium, 24 receivers (7 of which are hearing aid compatible) should be available for the auditorium, 36 receivers (9 of which need to be hearing aid compatible) should be available for the gym, and four (4) receivers (2 of which need to be hearing aid compatible) should be available for the auxiliary theater.

Note: In each assembly area where audible communication is integral to the use of the space, an assistive listening system must be provided, and the assistive listening system shall be identified by a sign with the International Symbol of Access for Hearing Loss. The ADA 2010 Standards Section 219 outlines the type of receivers that are required based on the capacity of each assembly area.

Multi-User Toilet Rooms

Accessibility issues include lack of compliant lavatories with knee and toe clearance, dispensers that act as protruding objects, accessible toilet compartments that are narrower than allowed, accessible compartments that lack door pulls on each side, a urinal with an inoperable control, toilets and grab bars that are located improperly and toilet seats that are lower than allowed.

Shower Rooms, Changing Rooms and Locker Rooms

Accessibility issues at Family Changing Room A and B include lack of compliant lavatories, lack adequate clear floor space at the toilet, toilets located closer to the side wall than allowed, grab bars that are mounted improperly, dispensers mounted over grab bars, lack of knee clearance at the changing room table, and lack of clear floor space alongside the bench. At the transfer shower compartment in Family Changing Rooms A and B, the size of the shower compartment is not compliant, the grab bars and seat are mounted improperly and the seat is not padded.

Accessibility issues at the men's and women's locker rooms include noncompliant locker room benches, dispensers acting as protruding objects, lavatories acting as protruding objects, malfunctioning self-closing hinges, and lack of a door pull on each side of the door of the accessible toilet compartment, and a toilet paper dispenser located over the grab bar. Issues with the shower compartments in the locker rooms include lack of clear space at the transfer shower, grab bars mounted improperly, a compartment with a noncompliant size, and lack of a padded seat at each shower compartment.

Accessibility issues include drinking fountains for standing users located lower than allowed, drinking fountains for seated users that lack knee or toe clearance, and drinking fountains that act as protruding objects in the circulation path.

*Note: IHCD is not providing costs for some exterior issues such as estimating the cost to repair or provide expanses of sidewalk and walkways. The cost to renovate the auditorium, gymnasium and auxiliary theater and provide accessible seating needs further analysis. The cost to provide accessible lockers by the family changing rooms is not provided.

Best Practice and Inclusive Design

Best practice and inclusive design recommendations include elements that are not required in the standards but may create enhanced experiences for all users.

- Recommend providing contrast strips along the full tread on both stairs on the sides of the stage of the auditorium.
- Recommend installing lights at the stair. IHCD recommends providing 10 foot candles in this area.
- Recommend the soccer goals to be moved out of the path of circulation, even if there currently exists a 36" clear path on the routes by the soccer field.
- Recommend these accessible spaces be located on the east side of the north lot by the multipurpose field as there are no accessible parking spaces in this location.
- Recommend as best practice to extend the striping so that the crosswalks connect at the parking by the main entrance to the auditorium.
