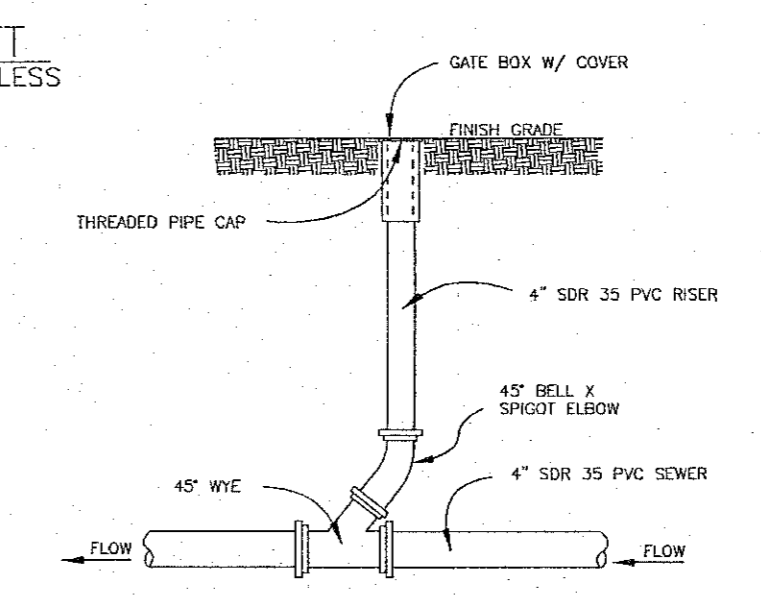
DRAINAGE STRUCTURE SEDIMENT TRAP

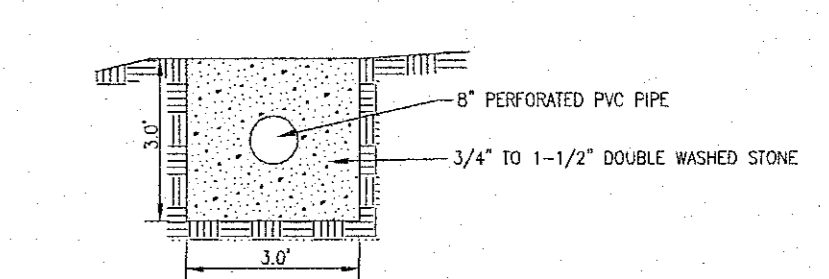


SEWER CLEANOUT DETAIL (C/O)

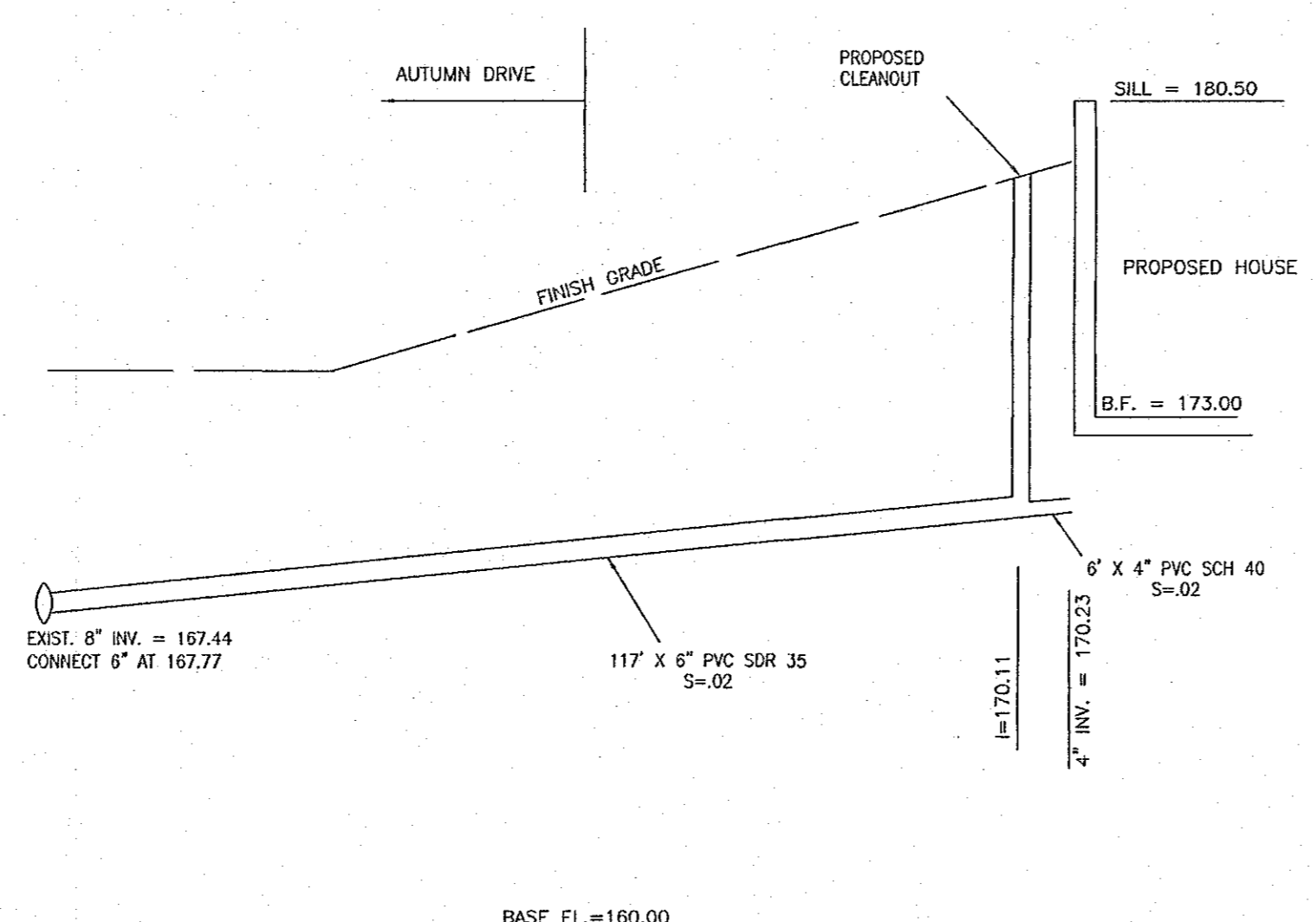

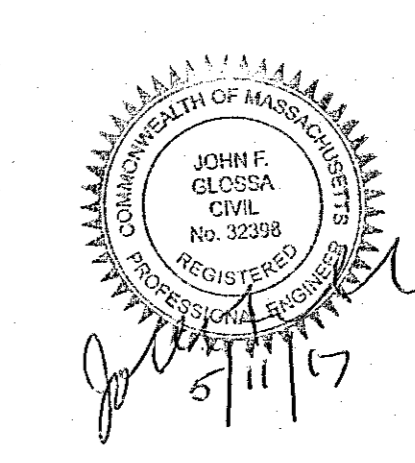
