The Westwood Planning Board will hold a public hearing on *Tuesday, February 26, 2019 at 7:00 PM* in the Champagne Meeting Room at the Carby Street Municipal Office Building, 50 Carby Street, Westwood, Massachusetts 02090, regarding an application filed by Saint Mark of Ephesus Orthodox Cathedral for a Limited Environmental Impact and Design Review (EIDR), pursuant to Section 7.3 of the Westwood Zoning Bylaw. The application purposes constructing a new entrance on the west side of the building including an accessible entrance to the main level of the Cathedral at 340 Clapboardtree Street, Westwood, MA 02090 also known as Assessor's Map 21, Lot 064.

The property is in the Single Residence E (SRE) zoning district and the Wireless Communications Overlay District (WCOD). Presently on the property is the existing Saint Mark of Ephesus Orthodox Cathedral.

In the event inclement weather necessitates canceling the public hearing, the public hearing will be continued to a "snow date" of Tuesday, March 12, 2019 at 7:00 PM in the Downey School Cafeteria located at 250 Downey Street, Westwood, Massachusetts 02090. In such an event, the notice will be posted on the front door of Carby Street Municipal Office Building on February 26, 2019 announcing the meeting cancelation and continued meeting date on March 12, 2019 at the Downey School Cafeteria.
