## NOTICE OF PUBLIC HEARING 45 CLAPBOARDTREE STREET

The Westwood Planning Board will hold a public hearing on Tuesday, March 12, 2019 at 7:00 PM in the Downey Elementary School Cafeteria located at 250 Downey Street, Westwood, Massachusetts 02090, regarding an application filed by The Green Company for a Special Permit, pursuant to Section 8.3 [Open Space Residential Development] of the Westwood Zoning Bylaw and the Planning Board's Subdivision Rules and Regulations where applicable. The Application proposes purposes to construct a 20 ft. wide road to access forty (40) new age-restricted residential dwellings, thirty-eight (38) of which are townhome duplex style and two (2) are detached single units. The Project includes preserving the existing field and 40 parking spaces, open space areas, each residence includes a two car garage with a driveway and 17 visitor spaces provided throughout the site. A meeting facility, stormwater management, landscaping, and associated site work is proposed.

Land Affected: 45 Clapboardtree Street, Westwood, MA 02090 also known as Assessor's Map 29, Lot 123. The property is in the Single Residence C (SRC) zoning district. Presently on the property is the former Westwood Lodge Hospital.
