**NOTICE OF PUBLIC HEARING**  
**690 Canton Street**

The Westwood Planning Board will hold a public hearing on *Tuesday, June 25, 2019 at 7:00 PM in the Champagne Meeting Room at the Carby Street Municipal Office Building, 50 Carby Street, Westwood, Massachusetts 02090*, regarding an application filed by New Cingular Wireless PCS, LLC on behalf of AT&T, for a Wireless Communication Overlay District (WCOD) and an Environmental Impact & Design Review (EIDR), pursuant to Section 7.3 and Section 9.4 of the Westwood Zoning Bylaw. The Applicant proposes to modify its existing base station by: installing one (1) additional skid mount; collocate three (3) new antennas on the new skid mount for a total of fifteen (15) panel antennas; and shifting the existing panel antennas to achieve proper antenna separation. AT&T will also install four (4) additional Remote Radio Units (RRUs) and one (1) surge arrestor, cable and fiber, as well as replace equipment within the equipment room on the roof of 690 Canton Street, Westwood, MA 02090. The property also known as Assessor's Map 37, Lot 009. The property is located in the Wireless Communications Overlay District (WCOD) and the Industrial (I) zoning district.
