### NOTICE OF PUBLIC HEARING WESTVIEW ESTATES DEFINITIVE SUBDIVISION AMENDMENT THOMPSON AVENUE TUESDAY, SEPTEMBER 5, 2017

The Westwood Planning Board will hold a public hearing on ***Tuesday, September 5, 2017 at 7:00 PM in the Champagne Meeting Room at 50 Carby Street, Westwood, Massachusetts 02090***, pursuant to M.G.L. Chapter 41, Section 81W [Modification, amendment or rescission of approval of plan; conditions] and its Rules and Regulations Governing the Subdivision of Land.

The Applicant, Cornerstone Corporation, is requesting a modification of the approved Definitive Subdivision of Westview Estates to modify the tree plantings as shown on the approved plans entitled "Construction revisions for 'Westview Estates' Definitive Subdivision in Westwood, Massachusetts", dated November 10, 2010 and revised through February 8, 2012. The approved plans include trees to be located every 30 feet.
