**Wight Lane and 9 Hedgerow Lane  
"Westwood Estates"**

The Westwood Planning Board will hold a public meeting on **Tuesday, December 15, 2015 at 7:30 PM** in the Champagne Meeting Room at the Carby Street Municipal Office Building, 50 Carby Street, Westwood, Massachusetts 02090, regarding an application filed by Canton Street Realty Trust for a Preliminary Subdivision, pursuant to the Planning Board's Rules and Regulations Governing the Subdivision of Land and Westwood Zoning Bylaw, to subdivide the lot at the end of Wight Lane into ten single-family lots for property also known as Assessor's Map 32, Lot 009, and construct a ~1,110 ft. road beginning at 9 Hedgerow Lane (Assessor's Map 32, Lot 197) to extend into the Wight Lane property (Map 32, Lot 009).

The properties are located in the Single Residence C (SRC) zoning district. The subject property at the end of Wight Lane consists of 10 acres and presently has a single-family residence and a single-family residence located on the 1 acre property at 9 Hedgerow Lane.

The plans and application are available for inspection between 8:30 a.m. and 1:00 p.m., Monday through Friday at the office of the Planning Board at Carby Street Municipal Building or during regular municipal business hours at the Town Clerk's office.
